Hello H&I subcommittee,

At our last subcommittee meeting on Feb. 6th, 2023, I was voted in as panel coordinator for the Northeastern Regional Adult Detention Center. It was my understanding from the previous panel coordinator, Mike H, that our contact for NRADC, Josh Hoshman, requested NA to have inmates sign the roster sheet that we fill out when we carry the meeting. The next day I called Josh, he told me that the captain is requiring the inmates to sign the roster. I explained the agreement that we have in our guidelines to only put the number of inmates attending in the H&I meeting. Josh said he would talk to the captain and let me know if that will continue. That afternoon Josh called me back to tell me that we can suspend the program until we meet with the captain. I was scheduled to go in that Wednesday Feb. 8th, and I asked Stephen P. to go in with me but the captain set up a meeting on that Thursday the 9th at 1p, so we did not go in.

I contacted the H&I Chair, Linda A, and asked if she would accompany me on the 9th to meet with Captain Cortrell. Linda agreed. We met with Captain Cortrell and showed him our H&I guidelines with the previous agreement. Captain Cortrell told us that we will not be responsible for the roster getting signed by the inmates, the officers will be responsible for that. We will fill out the top of the roster, put it on the table and the deputy will handle things from there. We can change the guidelines to reflect this change.

On February 22nd, Danny M. and Peyton C. went in and had 6 inmates attend the meeting. It was noted that the deputy did not get the roster signed. Josh had approved us to go in with the new change.

I talked with Mike H. and he will give me what he has tonight (applications). The orientation was scheduled for Wednesday, March 8th

I have scheduled Randy D. and Peyton C. for the 8th of March and Danny M. with Stephen P. on the 22nd of March.
