- **REGIONAL OPEN POSITIONS & MOTIONS**

Sarah M presented the Regional Motion which was set forth to mirror the WSC World Conference Schedule. Since the presumption is that the RD-2 and then the RDA positions are learning roles and create a pathway to be the RD, the term and the commitment for RDA and RD-2 would be extended. Terms from 2 to 3 years and the RDA Commitment from 4 to 6 years and RD-2 from 6 to 9 years. Concerns voiced about this length of commitment being a possible deterrent to getting trusted servants.

TAKE THIS MOTION BACK TO HOME GROUPS

- NEW BUSINESS

Three Area Motions were presented by Luke T, all seconded by Heather R., read during ASC and will be sent to Secretary to include along with the intent for each motion.

From the Notetaker: the discussion was very passionate and hard to keep up with. Some people (like your notetaker) had comments important to them that could not be categorized into Question/Pro/Con. I did my best to capture any Questions, Pros and Cons for each motion.

There was a lot of discussion about August ASC and references to past ASCs where there were feelings of disparate treatment with some being held to One Year clean time and others not. At one point it was requested that if we needed to have discussion on past ASCs that it be done without continuing to reference people by name which felt hurtful and not spiritual. Also, the motions were offered in the spirit of allowing us to learn from and move forward from past rather than continue to belabor it

FIRST MOTION

- Date: 9/11/2023
- Motion Maker: Luke T. Second By: Heather R.
- Article: 5 Section: 3 Item: 2 Motion: I motion to alter the guidelines to change “suggested” to “required” under WHO in the Nominations section of the guidelines. The edited version would read “It is required that a continuous clean time of one year be a guideline when considering nominees.”
- Intent: The primary purpose of this motion is to uphold the 4th Concept for NA Service which states that “Effective leadership is highly valued in Narcotics Anonymous. Leadership qualities should be carefully considered when selecting trusted servants.” It is observable that this section of the guidelines is frequently presented as a requirement. So, the change of language would ensure all members of NA are treated equally in keeping with our spiritual principles. Additionally, this motion will ensure the Area Service body remains impartial in selecting trusted servants; seeing as “the final responsibility and authority lies with the NA groups.” The 7th and 9th Concept for NA Service states that, “All members of a service body bear substantial responsibility for that body’s decisions and should be allowed to fully participate in its decision-making processes,” and that “All elements of our service structure have the responsibility to carefully consider all viewpoints in their decision-making processes,” so this motion would not restrict any member from participating at the Area Service Committee.
- **Summary – Motion to Change word “Suggested” as it appears in clean time** requirement for Area Subcommittee Chairs to “Required”
QUESTION: Who would motion pertain to? A. Not GSRs, just those serving in Area role.
QUESTION: Will motion change all occurrences of word ‘suggested’? A. only one occurrence of word suggested found.
PRO: Consistency of language throughout guidelines.
PRO: Could do a disservice to the addict to put them in an area role too soon
CON: This motion feels exclusive and not inclusive, quantity of time is not the only or best determiner of ability to serve.
CON: Does not allow for any flexibility.

TAKE BACK TO HOME GROUPS.

SECOND MOTION

- Date: 9/11/2023
- Motion Maker: Luke T. Second By: Heather R.
- Article: 7 Motion: In order to clarify the intent under Article 7 of the area guidelines, I motion to add an additional section to address a loss of abstinence in regards to trusted servants. The section would read as follows: 7.4 Loss of Abstinence “In the case of a loss of abstinence the affected ASC position shall be declared vacant.”
- Intent: Article 7 states that “Except in the case of loss of abstinence, a two thirds (2/3) vote is required for their removal.” This statement begs the question of what “except in the case of loss of abstinence” refers to since it is not clarified in the article. Again, this motion would uphold our 4th Concept for NA Service “Effective leadership is highly valued in Narcotics Anonymous. Leadership qualities should be carefully considered when selecting trusted servants.” Loss of abstinence means that one of the qualifications trusted servants were elected based off of is no longer the case, this undermines the group conscience which is the basis for all decisions of our fellowship. Even though the action of removing a trusted servant is difficult in the case of a loss of abstinence removal is not solely disciplinary, but an act of love so that our members can focus on their recovery. Like in the previous motion, this does not restrict members from having a voice in the Area Service Committee. We have countless, crucial subcommittees that require dedicated members and are lacking in participation.

- **Summary – original motion added ‘upon loss of abstinence the Trusted Servant would be required to relinquish their role. This was later amended/ revised to read ‘upon loss of abstinence the position would immediately become vacant.**

QUESTION: If approved, when would this take effect? A. Moving Forward for any future elections.

CONCERN: Concern voiced over the use of term required prompted motion-maker to reword the motion.

PRO: This motion would resolve the inconsistency in how/when a person would not be able to be elected or would have to leave their role.

PRO: Follow up to above – the inconsistency in how guidelines are implemented could be a deterrent to people wanting to serve

CON: Dealing with this situation in such an absolute way in all cases could make someone reluctant to admit to their loss of abstinence.

CON: Follow up to above – not all situations are the same; flexibility does not always equal favoritism.

TAKE BACK TO HOME GROUPS.

THIRD MOTION

- Date: 9/11/2023
- Motion Maker: Luke T. Second By: Heather R.
- Motion: To remove our Regional Committee Member Alternate.
- Intent: The RCM Alternate has expressed the desire to remain in their position and some members of the Area Service Committee have supported them in remaining in their position,

however at this time does not possess the suggested clean time. Due to the large discrepancy between the RCM Alternate's current clean time and the suggested clean time of 1 year the NA groups must be the deciding factor in this instance. Additionally, the guidelines state "Except in the case of loss of abstinence, a two thirds (2/3) vote is required for their removal." The guidelines fail to elaborate on what "Except in the case of loss of abstinence" refers to, so, it needs to be the groups who decide how to interpret this statement in this instance. The Area Service Committee can choose to go against the guidelines at any time but cannot do so without first consulting the groups who are "The final authority for NA service" as stated in 2nd Concept for NA Service. Any decision made in the Area Service Committee which goes against the guidelines, which the groups approved by way of a group conscience, indicates that the service body is in violation of our 2nd tradition which states "our leaders are but trusted servants; they do not govern." The RCM Alternate's removal would not restrict them from shadowing the Regional Committee Member and attending the CARNA Regional Service Committee meetings. Lastly, this past year when elections were held multiple members with less than a year clean were told they could not run for positions until they had the suggested clean time. Our fellowship was founded on the principle that we are all equal and that no member is above any other. What example are we setting for newcomers if we are lenient with our traditions, concepts, and guidelines?

○ **Summary – motion for removal of RCM-Alt.**

CON: Harm to the addict by having this discussion at group consciences throughout the area

CON: Nothing positive served by this motion. The previous two were intended as positives steps to the future. This one does not feel spiritual or solution-oriented.

There was discussion as to whether or not this motion was Procedural and could therefore be voted on this evening and resolved or if it was Structural. Due to time it was about to be Tabled, but since a request had been made to send it back, the decision was to send it back to Home Groups for vote.
