  I was not able to attend the last RSC due to a conflict but the RCM alternate did attend in my absence.

I attended the most recent RSC meeting on June 17th and carried our area vote in favor of the Debit Card Motion 219-1. This motion did pass.

Roland nominated Sherry for RD; 8 votes in favor; 0 against; 1 abstention.

Sherry V. nominated Roland C. for Vice-Chair, Roland C. provided qualifications; voted in unanimously. (This position had been open for at least two RSC's).

2:02 New Business – Barbara S., of the SheVANA Area (GSR Sisters in Spirit), wanted to make a "motion to eliminate the position of RDA-2 and amend policy and budget to delete references and budgeted expenses for this position." Chelsea R. supported the motion and would have seconded the motion if it were voted on. The motion maker will need to be present to a Regional meeting in order for the next steps to be made.

Intent: Now that the WSC will be every three years, filling this position and retaining that elected member could be much more of a problem. We want service to be attractive and to support our elected officers to fulfill the entirety of their term. CARNA may already currently be one of only a couple of

Regions who even has this position. This represents a potential savings of \$4,000 - \$5,000 annually based on current budget that could then be sent on to the world or reallocated as needed.

Because this motion maker was not present, and because an individual brought the "proxy call" instead of the Area, the Chair decided to table this motion and discuss this at the next Region or when the motion is presented in person.

- Sarah M. reread part of the RCM Alternate's Report regarding positions that are filled and positions that are open.

#### **OPEN FORUM:**

- 1. The Seventh Concept was read.
- 2. A member brought up that some home groups are only reading portions of the Steps, Traditions, etc. in NA meetings. Home Groups are able to "do what they want" and are autonomous. Members of the body voiced concerns with not reading the readings during NA meetings but that decision rests within each home group.
- **3.** A question was raised about if someone relapses if the person should stay in the position. An option is for someone to step down since there are clean time requirements for trusted service positions in area service. There are ways to be kind and compassionate and allow someone to step down from the position. Guidelines were reviewed.
- 4. Frustrations/concerns were raised about rigidity and following guidelines on inconsequential matters. Roll call was done by the Secretary this evening and the Chair redid the roll call based on the guidelines. Concerns were raised as to what guidelines we follow and who decides that. Discussion occurred regarding this issue, and we should be careful and mindful of our intent. Private conversations are encouraged when someone has made a mistake. Guidelines are here for us to follow and none of us have them all memorized.
- **5.** The Secretary will email the Chair information about guidelines that were changed a few months ago.
- **6.** Are we open to having coffee at ASC? We used to have coffee in the 80's! Donated coffee pot is a possibility! Tony B. has a coffee pot.
- 7. H&I Wendy needs updated minutes and guidelines. Last update was completed in 2021. If the Secretary of H&I is able to email the PR Chair the updated information, that would be great. We have not had Special Events minutes online in the past. Events are posted.
