

### NEW BUSINESS

The VRCC Business Meeting is <u>Saturday May 20<sup>th</sup> – Open Forum starts at 1 pm</u>. New Business will be discussed from 2-5 pm. Included below is a summary of the discussion from our ASC meeting.

- Randy believed that using the term of "centralization" for the AVCNA is incorrect.
- It was brought up that the three-city rotation would be a disservice for the other areas.
- Michelle is willing to report our group conscience to the VRCC.
- Stephen likes the idea of the three-city rotation and posed a question that if there are no bids then perhaps the three-city rotation could be used.
- Barbara S. asked if financial mistakes from the past could be explored and asked if there could be another solution outside of the three-city standardization.
- Norman C. said it would be shame to eliminate the opportunity from the experience that others had in putting on the AVCNA.
- We do not have a currently a VRCC Director or Alternate and we are missing out to provide input regarding the AVCNA. Meredith shared that service work at the AVCNA was her "favorite" position. Also, our area typically has to find a hotel outside of Winchester because there is a not a hotel in the area that is large enough to accommodate the number of attendees.
- Drew P. asked if the AVCNA rotation is designed to reach the max amount of people and that feels like a good thing.
- Paul G. asked about areas hosting in the three-city rotation.
- Linda A. read the Motion again which was also in last month's minutes.
- The VRCC is struggling with people showing up as well as the Regional. Our Area is also able to send a representative to the VRCC meeting to report our area's conscience. Meredith nominated Stephen P. as pro temp VRCC Chair. Norman C. explained the Guidelines that this motion would need to be voted on by home groups. We have done this before for Roberts Rule of Order and emergency votes were voted via email and texts. It is not an option to send out a vote because it must be voted on the floor tonight. Stephen P. has a sponsor and does not have a home group and will

have one within the next 24-hours. Stephen politely said "no" and then said, "I am willing to do it." Emergency vote is able to be included in the minutes and this would be the Secretary's responsibility.

- Meredith explained that we have spent a lot of time on this tonight, and this may be our learning opportunity to have a trusted servant in the position. By the end of the meeting, we had lost quorum nor decided how we would vote (there was only discussion that occurred). Stephen does plan on attending the VRCC Meeting.
- Nora then nominated Stephen P. for VRCC Director. Heather R. seconded the Motion. Michelle M. read the qualifications. Stephen accepted the nomination and stated his qualifications which are included below.




