**<u>Reduce</u>** Special Events prudent reserve from \$1,000 to \$700.

**Intent:** To be financially responsible. Any event S.E. has put on has never needed nor used or come close to \$1,000. It also gives S.E. the option to pass on funds in excess of new and previous prudent reserves of \$700.

**Questions:** 1. Can Special Events request extra funds if they needed more than \$700? Yes, but it would have to be approved by GSR's

- **LITERATURE REPORT:** Augusta W. Present and gave oral report and then submitted the following written report:

Hello ASC Family!

Literature held its first meeting on June 1 and Ashley W was elected as Vice-Chair of the subcommittee. There were four people in attendance and it was decided that while the Secretary position remains open, the Vice-Chair would take on the responsibilities of Secretary at Business Meetings until one is elected by the subcommittee. The Chair holds the duties of Treasurer. We held a second meeting on June 8 with five people in attendance and began the task of reviewing the 2017 SheVANA Literature Subcommittee Guidelines to update. We will continue working on that project until the task is completed, at which time the new guidelines will be provided at the ASC meeting following completion.

The subcommittee decided that we will hold monthly business meetings on the Saturday following the monthly ASC meeting, 10 am, at Edgehill. This will allow for a group consensus on what should be ordered from NAWS that month based on GSR orders and allow review of our financial standing to determine whether we are at Prudent Reserve or over, in which case donations to the service structure can then be voted on.

Literature will be creating a list of the suggested minimum stockpile of inventory it should hold to meet the ASC needs. Literature will begin storing the bins and inventory in the ASC storage unit upon receipt of a key. We will no longer be hauling the inventory in its entirety to each ASC business meeting to follow the NAWS Handbook for Literature Committees, as it is suggested to bring the top 10% of the most in demand items. We will continue to bring all fulfilled orders, all medallions, all keys tags and then as suggested, the top 10% of in demand books.

The next Literature Subcommittee meeting is June 15th, 10 am at Edgehill. The current standing of funds is \$379.60 at the time the oral report was given to the June ASC meeting. We have included an attachment (SLSCRA.6.10.24) to this written Chair report that has the full financial report, full current inventory and a copy of the last Literature Subcommittee's business meeting minutes.
