Motion Maker: Michelle M Seconded by: Danny M

Motion: To increase our prudent reserve by \$500 to cover approved expenses for the VRCC and RCM travel and to add expenses under duties and make financial changes on Article 14.

Intent: To ensure we have funds to cover approved expenses for VRCC and RCM.

It is currently \$1600, this would bring this to the prudent reserve to \$2100.

Questions:

So, once a year you might have to send the VRCC and RCM out and cover their expenses, would we pay that per month or per year? Typically we do not have to pay for the RCM, however, this time we did have to pay for this. Is \$500 enough because we have 2 two-days? Yes, because there is time to recoup the prudent reserve in between the two-days. Main focus is the VRCC because theirs is not covered. It will always be \$2100, if there is any overage, the overage still goes to Region each month. So, we are raising this to ensure we are able to send people to the necessary meetings.

To update the guidelines, where will this need to go? Wendy suggested an amendment to clarify where this will go in the guidelines
