OPEN FORUM:

Concept of the month read by Bailey.

What are our monthly bills? \$227.99 for just the area are. However, H&I has a request for literature, we cannot pay this, if there is any PR we cannot pay that, no non-standing budget requests can be paid. Why is the literature not getting paid? Actively, right now, we can, but next month we cannot pay our bills. I am afraid if we write a check for H&I literature that we cannot pay our bills.

So, what can H&I do to get literature? Can we get a front?

I have not seen this since I have been a part of the area, my thoughts are that we are in uncharted territory and we need to make some hard decisions about what we are going to do financially. Maybe we will need to freeze our assets. We need to try to get donations from our homegroups. The treasurer suggested that we not donate to CARNA, but the body voted to send the \$1000 plus to CARNA. Please remember this when a trusted servant makes a suggestion.

H&I – are you out of literature or can we revisit this next month?

Maybe we need to change policy on that.

Literature has enough money to cover H&I this month.

Would it be against anything to do a fundraiser for area?

I feel like Déjà vu from a couple years ago and we needed to make sure the groups were donating. I think it was sent back to groups to push to get donations for area. We have never been in a financial situations this dire.

PR wants to apologize to H&I. I was supposed to come to your meeting this month and totally forgot.

So, the are, we have money, we have literature and special events money. Is there any way we can transfer money from one account to the next? Technically, ASC is the umbrella.

As of right now, we cannot conduct any business.

Thanks to the treasurer and everyone. A few things, like, this is the perfect storm of not meeting quorum, the groups that typically donate big are not here. Take this back to your homegroups with the financial stress we are going through. Every group is autonomous and can decide how to spend their money. Because of inflation everywhere, less money is coming into this building. Groups have done fundraisers. In doing fundraisers you are networking, and creating a way to support your group and then the area.

I think we spend about \$1300 on the storage unit. It is my understanding that special events uses the storage unit. Has anyone accessed the storage unit recently? Perhaps we can look at a different solution for storage.

In re to the storage unit, is this is the only place that has kept the rent the same for the duration of the contract. We have tried storing it at someone's house. The storage unit is a necessity. I implore anyone to find a more affordable storage unit.
